The board for the Town of Hammond held their regular monthly meeting on Monday, May 13, 2024, at the Hammond Town Hall at 1816 County Road E immediately following the 2024 Annual meeting.

Chairman Hueg called the Town of Hammond Board meeting to order at 8:00 pm.

The agenda was approved motion by Anderson/Aune second.

The bills and payments were approved; motion by WynveenAnderson second.

Planning Commission; All members present. They reviewed the building permit for Maximo Sarango. They also reviewed the CSM for Zack Gillis.

Paul reported the road work, culverts and the tree's on 100<sup>th</sup> and 170<sup>th</sup>. Paul updated the committee on the cyclone fence bid for the all field.

Agenda:

Annual Report – Tabled to do unfinished at the time of meeting.

Zack Gillis – CSM approval, motion to approve Anderson/Wynveen second.

Maximo Sarango - There was discussion from the residents that Sarango is still doing late night parties and loud music. The board tabled the permit approval. Paul will contact All-Croix and discuss situation.

SCC Rec – Justin was present to discuss the addition of dug-outs on the current slabs. They will be responsible for cost (8 x 30 3 sides). Paul reported the cost of the fence was \$10,638 for the 6' x 400, \$8,275 for the 4 x 400. The Rec will pay the difference between the two. Paul said we could use ARPA funds for this project; motion by Wynveen/Anderson second. The Rec will purchase new bleachers.

HGC/Pheasant hills – Reviewed the license renewals will approve at the June meeting.

2024 BOR – motion by Anderson/Aune second to open/close the BOR meeting until July 30, 2024, Open book July 23.

Roads:

Paul presented a list of roads that will need work. 14 miles will need spray patch, chip seal, and fogging. The cost will be \$357,581.51. He laid out a plan where we can do all the work and finish 110<sup>th</sup> Ave., with current funds. Motion by Aune/Anderson second. (Linda has list of roads and funding if anyone would like to review).

Chairmans report: Paul reported he talked with Monicken about fixing the outside lights. Paul asked Linda to send letter to the resident on 160<sup>th</sup> St. for tree removal. Paul will put up sign for the playground, Linda will order signs for no smoking and no dogs on ball fields.
